Bay Area voters’ approval of Measure AA this June was the biggest win for our Bay in decades, and it never could have happened without Save The Bay’s supporters. Our victory will mean cleaner water, more abundant wildlife, and greater climate change resilience for our Bay. Because of Measure AA, we’re on track to pass a healthier and more vibrant Bay on to our children and grandchildren.

This game-changing victory is the culmination of more than a decade of work by Save The Bay. Starting in 2018 it will generate \$500 million for restoration of San Francisco Bay wetlands.

Rebirth of a Movement

More than 70 percent of voters—or more than a million individuals—came together to deliver a resounding victory for wildlife and people who want a healthy, beautiful Bay for future generations. To us, it signals the next phase of the movement started by Sylvia McLaughlin, Kay Kerr and Esther Gulick more than a half-century ago.

Our Measure AA victory gives us enormous momentum to tackle the biggest threats to our region in the coming decades—pollution and climate change. The partnerships we built and people we’ve mobilized will do so much more together to protect and restore San Francisco Bay for wildlife and people.

Getting Closer to Zero

Our *Zero Trash, Zero Excuse* campaign reached a major milestone in November when the Regional Water Board heard Save The Bay supporters' outpouring of opposition to trash flowing into our Bay, and responded by passing a stronger stormwater permit that does more than ever to regulate this pollution. Since then we've also helped pass and strengthen outdoor smoking bans in the East Bay Regional Park District and Sunnyvale, and a long-overdue bag ban in the city of Milpitas. With your support, we will keep fighting to stop toxic, plastic pollution from finding its way to our Bay. Now we're working closely with Bay Area cities to ensure they meet their obligations to get to zero trash flowing into the Bay by 2022.

Your Next Step:

Disposable plastic bags entangle, suffocate, and poison hundreds of animal species worldwide, including sea turtles, birds, and marine mammals. Bring a reusable bag with you to the store. And vote YES on Prop 67 to ban the bag once and for all in California.

Bay Day: A Huge Success

On Oct. 1, Bay Area residents from every corner of the region came together to celebrate the first-ever Bay Day. Save The Bay created this official day of celebration in order to reach, not just thousands, but millions of residents with our message about a clean, healthy Bay. We convinced cities around the Bay Area to officially recognize Bay Day, and dozens of community partners hosted public events.



Next year, Bay Day will be Saturday, October 7—and it's guaranteed to be even bigger.

New Priorities for the Future of the Bay

Save The Bay’s staff and Board of Directors dedicated much of 2015 to a deep examination of our mission and programs, and we’ve charted a bold vision for protecting and restoring the Bay in the decades ahead.

Our strategy continues our work to restore Bay habitat through sound science and tenacious advocacy. It also embraces new work to make Bay Area communities “Bay Smart.” Bay Smart means promoting nature-based solutions to stormwater pollution prevention, fresh water conservation, filtration, and storage – like “greener streets” with rain gardens, permeable surfaces, shade trees and other sustainable design elements, as well as progressive new water-use and re-use standards for new developments.

It also means we will be supporting a broader set of sustainable and equitable development practices to reduce energy use and emissions of greenhouse gases that fuel climate change, address the disproportionate impacts of sea-level rise upon disadvantaged communities, and expand public access to the shoreline.

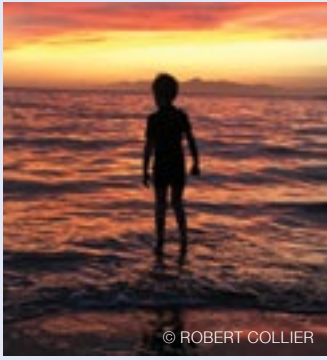

100,000 Plants and Counting

It's hard to visualize 100,000 California native plants. But it's exciting to think of the habitat they will create when fully established at our restoration sites around the San Francisco Bay.

In our last planting season, from October 2015 to April 2016, we reached our most ambitious goals to date with a grand total of **103,770 plants installed**.

Many of these plants were propagated and planted for the Oro Loma Horizontal Levee. This innovative project shows how natural systems can filter waste water, mitigate floods, and create native habitat along the Bay's edge. Today, the native plants we installed last winter are spreading over the horizontal levee's surface.

We planted an additional 30,000 plants at our other restoration sites around the Bay during this same period. It's never an easy job. With long days in the field, rain or shine, hands and knees in the mud, Save The Bay staff and volunteers work tirelessly to throughout the planting season. But the result—a healthier Bay for all of us—is worth it.

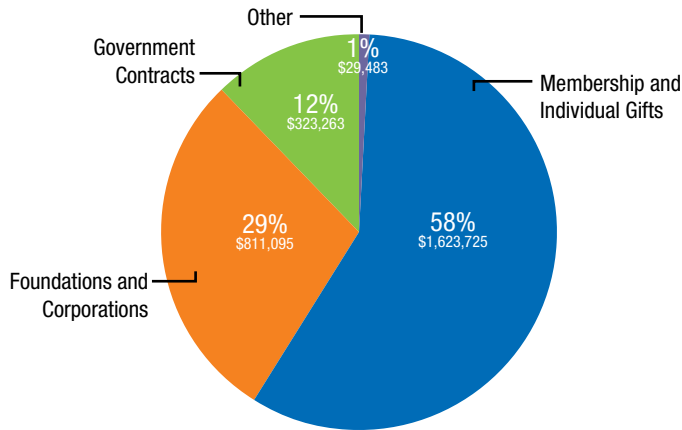

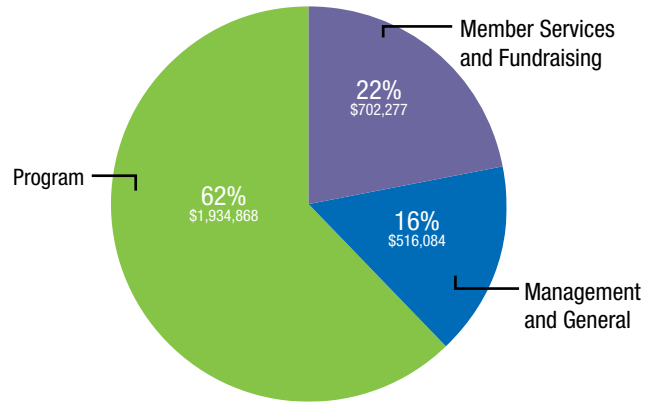
