SAVE THE BAY IS WORKING WITH PARTNERS TO RE-ESTABLISH 100,000 ACRES OF RESTORED TIDAL MARSH HABITAT AROUND SAN FRANCISCO BAY, THROUGH POLICY MEASURES AND A STRONG SCIENCE-BASED PROGRAM THAT ENLISTS VOLUNTEERS TO REPLANT KEY SITES WITH NATIVE VEGETATION.
